



NOTICE OF NOMINATION 2026 MUNICIPAL AND SCHOOL BOARD ELECTION

Municipal Elections Act, 1996 (s.32)

Notice is hereby given to the municipal electors of the Municipality of Lambton Shores

Nominations in the Municipality of Lambton Shores for the offices of:

Mayor	One (1) position to be elected at large
Deputy Mayor	One (1) position to be elected at large
Councillor	Seven (7) positions (one for each of the seven wards)

May be made by completing and filing in the office of the Clerk, nominations on the prescribed form and accompanied by the prescribed nomination filing fee of \$200.00 for the head of council and \$100.00 for all other offices. The filing fee is payable by cash, certified cheque, money order or debit.

The nomination of a person for an office on a Council must be endorsed by at least 25 persons in the prescribed form and in accordance with the Municipal Elections Act.

A nomination must be signed by the candidate and may be filed in person or by an agent during regular business hours between May 1, 2026 and August 20, 2026, and between 9:00 am and 2:00 pm on August 21, 2026 (Nomination Day).

In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, August 26, 2026, between the hours of 9 am and 2 pm and such additional nominations, if required, may be filed in the office of the Clerk.
