# **Public Meeting Notice**

# Your comments are welcome on Zoning By-Law Amendment Z12-2025 Date of Public Meeting: October 28th, 2025 at 7:00pm

A change is proposed in your neighbourhood:

The Applicant, Triple L Farms Inc. c/o Joseph Lacey is requesting an amendment to Zoning By-law 1 of 2003 as it affects portions of the farm parcel known as 9136 Arkona Rd. The applicant has also submitted an application for consent (file: B08/2025) to sever a "surplus farm dwelling" that was approved by the Committee of Adjustment. The applicant proposes to rezone the remnant portion of the farm to an agricultural zone that would prohibit a dwelling as required by provincial polices for surplus farm severances. The severed lot containing the surplus farm dwelling would maintain the current "Agricultural-1 (A1) Zone" designation.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Lambton Shores before the by-law is passed, the person or public body is not entitled to appeal the decision of the Municipality of Lambton Shores to the Ontario Land Tribunal. If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Lambton Shores before the proposed amendment is adopted or approved, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party
