TAKE NOTICE that the applicant is requesting one (1) minor variance from the Municipality of Lambton Shores Comprehensive Zoning By-Law 1 of 2003, Section 3.3.4 Lot Coverage of Accessory Building shall not exceed 93 m² (1,001 ft²) or 10% of the lot area, whichever is less. In this respect, the applicant has started to construct, without minor variance approval, a 64.5 m² (694.27 ft²) carport as an addition to an existing 53.5 m² (575.87 ft²) detached accessory building that will result in a total lot coverage of 118 m² (1,270.14 ft²).

Know Your Rights

If a person or public body does not make oral submissions at the public hearing or make written submissions to the Municipality of Lambton Shores Committee of Adjustment before the application is approved, the person or public body is not entitled to appeal the decision of the Committee of Adjustment to the Ontario Land Tribunal, unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

This will also entitle you to be advised of a possible Ontario Land Tribunal hearing. 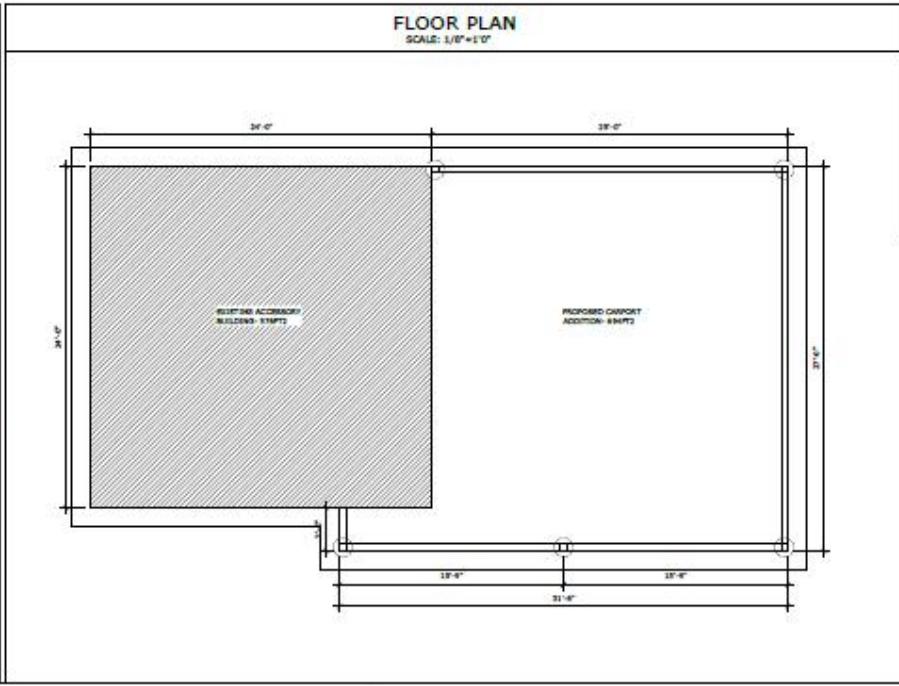

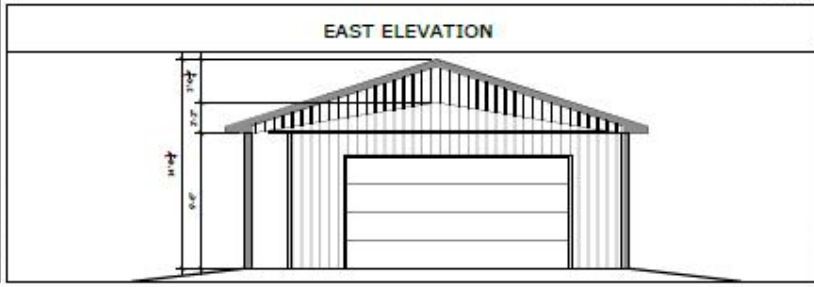
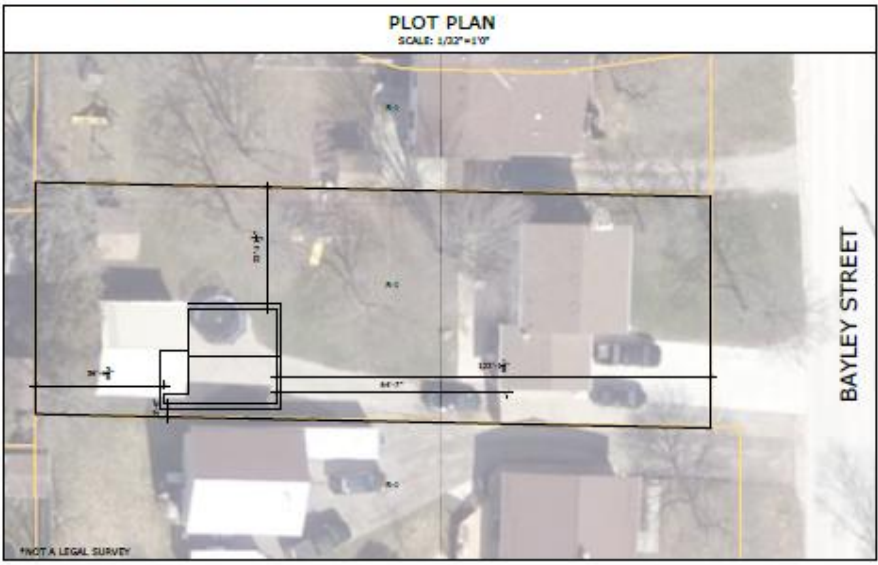
