TAKE NOTICE that an application for consent has been received. Application B15-2025 proposes a consent to sever an inadvertent lot merger by reestablishing the original two separate lots.

The proposed severed lot, containing the residential development, will front on Jennison Crescent, with a frontage of 24 m (80 ft) and a total lot area of approximately 2,035 m² (0.5 ac).

The proposed remnant lot, containing the commercial development, will front on Lakeshore Road, with a frontage of 60 m (200 ft) and a total lot area of approximately 1750 (0.4 ac).

This application was considered complete on November 13, 2025.

If a person or public body does not make oral submissions at the public hearing or make written submissions to the Municipality of Lambton Shores Committee of Adjustment before the application is approved, the person or public body is not entitled to appeal the decision of the Committee of Adjustment to the Ontario Land Tribunal, unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
